The use of unprofessional and uncalled-for observations at the bedside of the patient is calculated to infuse mistrust into the mind of the patient as well as the friends; and is always, amongst members of the Medical profession, declared to be at variance with every established rule of professional etiquette and that gentlemanty courtesy that should characterize the behaviour of professional men towards each other. The use of an unprofessional observation or "inuendo" might be of incalculable and lasting injury to a Medical practitioner; but, thanks to a well-earned reputation in this Town, and in the surrounding Country to the extent of at least one hundred miles, Dr. Hill feels himself perfectly secure against the slanderous and foul-mouthed insinuations of any individual who may thus ungenerously assail him. Nevertheless, he complains of such conduct "on principle."
