TO THE COUNCIL OF THE CORPORATION OF THE CITY OF TORONTO.

The Chamberlain begs leave to report herewith, an Abstract and Detailed Statement of the Receipts and Expenditure of the Corporation, for the year ending 31st December, 1868.

The total amount of Revenue received for the year, including the sum of \$51,553 66 which was in Bank, and in hand, on the 1st January, 1868, was \$803,921 41.

The amount of payments for the year, was \$692,208 84, which, with cash in Bank and on hand, 31st December, viz: \$111,712 57, amounts to \$803,921 41.

Annexed is an Abstract of the floating liabilities and assets of the Corporation, for the financial year ending 31st December, 1868.

Surplus Assets over Liabilities.....					10,410	08

The Statement of the Financial results of the year, showing a surplus of \$10,410 08, cannot fail to be satisfactory to the Council. This surplus arises principally from a larger amount of arrears of the taxes of the year 1867 having been received, and a larger amount received for commutation of Sewer rates, than was estimated, together with several Esplanade Awards having been paid in full.

The Chamberlain also begs leave to submit a Statement of the following Special Accounts, on the 31st December, 1868:

Public Walks and Gardens Fund.

Showing that the debt has been reduced during the past year by the sum of \$37,259 22. This gradual reduction of the debt must be a source of satisfaction to the citizens, and there is no doubt, that, in the present prosperous state of the City, a considerable reduction can be made during the present year.

The amount at the Credit of the Sinking Fund, on the 31st December, was \$178,678 88. The particulars of which are as follows:

The amount in process of collection is included in the Assessment Rate of 1868, a large proportion of which has been realized since the 31st December, and is now lodged in the Bank of Toronto. The amount at the Credit of the Fund in Bank, at this date (5th April) is \$112,405 92.

It is very important that the whole of this Fund, a considerable portion of which is only yielding four per cent. interest, should be immediately applied to the payment of the Debentures, for which the Fund was instituted. The Debentures might be purchased at a discount, and the amount thus invested would be a saving to the Corporation of about three per cent. per annum. The saving thus effected would be about three thousand dollars annually.
