MOST RESPECTFULLY REPRESENTS,-

That at a Quarterly Meeting or Session of the Municipal Council of the Municipality of the County of Vaudreuil, held at Vaudreuil, the thirteenth day of September, instant, it was resolved by the majority of the Municipal Councillors of the said County, who voted on a Motion to the effect of removing the head quarters to the little Village of Ruisseau St. Hyacinthe, that an humble Petition should be addressed to the Legislature of this Province at its present Session, praying it to be pleased to remove the head quarters of the County of Vaudreuil, as respects the administration of justice, the Registry Office and the sittings of the said Council, to the little Village of Ruisseau St. Hyacinthe, in the Parish of St. Ignace du Côteau-du-Lac, or any other suitable place in the centre of the said County, and to assure the Legislature, that in those places there are houses and premises to let, which would afford sufficient accommodation for the different Public Offices and the persons attached to them

Wherfore the Council humbly prays that Your Honorable House, considering the urgent motives of the present step, will be pleased to adopt the necessary Legislative proceedings to give effect to it, and that thereby the head quarters of the County, in which should be brought together the Public Offices, consisting of the Hall and Registry of the Circuit Court, the Registry Office, and the place of Meeting of the said Council of the said Municipality, be removed to and fixed at the little Village of Ruisseau Saint Hyacinthe, in the Parish of Saint Ignace du Côteau-du-Lac, or at any other place which Your Honorable House may consider the most central in the said County of Vaudreuil,

And the said Council, as in duty bound, will ever pray.

" The Secretary-Treasurer opens the sitting and presides until the nomination of the Mayor.

"After the nomination of Henri Cartier, Esquire, as Mayor of this Municipality, after the reading and adoption of the minutes of the last sitting, after the reading and reception of the petitions presented, after having passed to the orders of the day, and after having taken into consideration all the petitions presented this day, and having deliberated on each of them, "Mr. "Wilson, seconded by Mr. Lay, moves that an humble Petition be presented by the Secretary-" Treasurer of the Council, in the name of the said Council, to the Legislature at this Session, "praying it to be pleased to change the head quarters of this County, as regards the Administra-" tion of Justice, the Registry Office, and the sittings of the Council, and to fix them at the little "Village of Ruisseau Saint Hyacinthe, in the Parish of Saint Ignace du Côteau-du-Lac, or in " any other suitable place in the centre of the said County, assuring the Legislature that in those " places there are houses and premises to let which would afford sufficient accommodation for the " different public offices and the persons attached to them.

"Mr. Brosseau, seconded by Mr. Daoust, moves in amendment, that such a Petition be not "presented to the Legislature.

" The amendment is put to the vote.

"For it, Messrs. Brasseur, J. Daoust and J. Bte. Daoust-3.

"Against it, Messrs. Wilson, Lay, Leduc, Asselin, Charlebois, Bézènaire, Bertrand and "Verronneau-8.

" This amendment is lost by a majority of five votes against its adoption.

"Mr. McGrevy, seconded by Mr. Séguin, moves again in amendment, that the Address "to the Legislature, asking the removal of the head quarters, be for the purpose of having them "fixed near the Chapel of the Parish of Ste. Marthe, as being the centre of the County.

"For it, Messrs. McGrevy, Séguin, Beirne and Chalette-4.

"Against it, Messrs. Wilson, Lay, Leduc, Asselin, Charlebois, Bézènaire Bertrand and "Verronneau-8.

" Mr. Coutlée asks the Council to exempt him from voting on this question.

"Mr. Bertrand, seconded by Mr. Wilson, moves that the request of Coutlée be granted, and that he be exempted from voting.

" Mr. Brasseur, seconded by Mr. J. Daoust, proposes in amendment, that Mr. Coutlée be " not exempted from voting on this question.

" The amendment is put to the vote.

"For it, Messrs. Brasseur, J. Daoust, J. Bte. Daoust, Séguin, McGrevy and Beirne-7.

"Against it, Messrs. Bertrand, Wilson, Bézènaire, Verronneau, Lay, Asselin, Leduc and " Charlebois-8.

" This amendment is lost by a majority of one vote against its adoption.

" The principal motion is then put to the vote and carried on the same division.

" Consequently, Mr. Coutlée is exempted from voting.

" The second amendment, to the principal motion, to the effect that an humble Address be " presented to the Legislature for the removal of the head quarters, is lost by a majority of four " votes against its adoption.

"The principal motion is then put to the vote, those who voted against the said second " amendment, vote for the said principal motion, and those who voted for the said amendment, "vote against the said principal motion, making a majority of four votes in favor of the said " motion.

"In consequence, it is adopted, and the Secretary-Treasurer is ordered to draw up the " requisite Address in conformity with the said Resolution."

" After which, the Municipal Council proceeded to consider a letter addressed to the Mayor " of this Municipality by the Provincial Secretary to adopt several motions which were made and " to adjourn."
