# MINUTES OF COUNCIL.

#### FIRST MEETING

Of the Municipal Council of the Township of Scarboro', held pursuant to Statute, on the Third Monday in January (20th), 1862, at Mr. W. Johnston's.

The Clerk produced the Returns of the Elections for the several Wards of the Township, and declared the names of the persons elected Members of the Council for the current year—to wit:

The several Members elect having subscribed to the declarations of qualification and of office, the following motion was put and carried:—

Moved by Mr. Snider, seconded by Mr. Brown, that John P. Wheler, Esq., be elected Town Reeve for the current year. Carried.

Mr. Wheler, being duly elected Town Reeve for the current year, and having subscribed to the declaration of office as such, addressed the Council.

The Clerk then vacated the chair, and the Reeve took the same.

Moved by Mr. Brown, seconded by Mr. Snider, that John Crawford, Esq., be elected Deputy Reeve for the current year. Carried.

Mr. Crawford being declared duly elected Deputy Reeve for the current year, and having subscribed to the Declaration of Office as such, the Council organized, and proceeded to the business of the day.

Presented by Mr. Helliwell, petition of Widow Sanders, asking for relief.

Prayer of petition granted, and on motion of Mr. Helliwell, seconded by Mr. Crawford, that the sum of five dollars be granted for the relief of the Widow Sanders, and that the Reeve do grant an order for the same, payable to Mrs. Thorn. Carried.

On the question for the appointment of Auditors being put, it was moved by Mr. Crawford, seconded by Mr. Snider, that Christopher Thomson be appointed an Auditor for the year 1862. Carried.

Pursuant to Statute, the Reeve appointed Jas. A. Thomson as one of the Auditors for the year 1862.

Mr. Crawford, seconded by Mr. Brown, moved, that John Malcom be appointed Tavern Inspector, for the year 1862, at a salary of fifteen dollars. Carried, and the salary of fifteen dollars.

Moved by Mr. Brown, seconded by Mr. Crawford, that Daniel Ferguson be appointed Assessor for the current year, at a salary of sixty dollars. Carried.

#### BY-LAW No. 137.

For the appointment of Auditors, License Inspector, and Assessor.

The Corporation of the Township of Scarboro', enacts as follows:

That Christopher Thomson and James A. Thomson be appointed Auditors for the current year, at a salary of four dollars each; and that John Malcom be appointed License Inspector for the current year, at a salary of fifteen dollars; and that Daniel Ferguson be appointed Assessor for the current year, at a salary of sixty dollars.

Minutes of preceding meeting read and confirmed.

Presented by the Reeve, a petition to each branch of the Legislature, praying for the amendment of the Act 24th Vic., chap. 64.

Petition received and adopted.

Mr. Crawford, seconded by Mr. Helliwell, moved, that the following petitions, to both branches of the Legislature, praying for an Act to amend the Act passed in the 24th year of her Majesty's reign, intituled, an Act to confirm the side roads in the Township of Scarboro', be adopted, and that the Reeve be requested to forward a copy of the same to each branch of the Legislature. Carried.

To the Honorable the Legislative Council and Legislative Assembly of the Province of Canada, in Parliament assembled:

The petition of the Municipal Council of the Township of Scarboro',

HUMBLY SHEWETH,-

That your petitioners, at the last session of Parliament, obtained an Act to confirm certain side roads in the Township of Scarboro', and to provide for defining of other road allowances and lines in the said Township.

That authority was not therein given to your petitioners to define under the same survey, the lines of such side roads as had not then been opened, improved and travelled. That your petitioners have ascertained that it would be greatly to the advantage of the said Township, if all the side roads in the said Township were included in the same survey.

That the survey for which the said Act was granted has not yet been made, and your petitioners, therefore, humbly request, that the said Act may be so amended as to authorize an extension of the time therein specified to complete the said survey, and to include in such survey the establishment of such allowances for side roads as have not yet been opened, improved, and travelled.

And your petitioners, as in duty bound, will ever pray.

Mr. Crawford, seconded by Mr. Snider, moved that the Bill to amend the Act for the survey of the side roads in this Township, be referred back to a committee of the whole. Carried.

The Bill was read a first time, when the Council went into committee of the whole.

Mr. Crawford in the chair.

The committee rose, reported the Bill with certain amendments,

Read the second and third time.

Report received and adopted.

Mr. Grawford, seconded by Mr. Brown, moved, that the Reeve be and he is hereby requested to forward a copy of the Bill now adopted to the Member representing this Riding in the Legislature, and request his influence to have the same passed. Carried.

Mr. Brown moved, seconded by Mr. Snider, that the sum of fifteen dollars be granted to George Taylor and Thomas Brown, for the purpose of purchasing a suit of clothes and paying the passage of Brownald Trip to Rome, Oneida County, State of New York, said sum to be paid to the order of the Reeve. Carried.

The petition of David D. Thomson and others, praying to be allowed to perform the whole of their statute labor on the Markham Road, was read and laid on the table.

#### BY-LAW No. 138.

To prevent trespasses committed by Geese, Turkeys, and other poultry, within the limits of the Corporation of the Township of Scarboro'.

Whereas much inconvenience and loss have been sustained in consequence of there being no sufficient means of preventing of or punishing trespasses committed by Geese, Turkeys, or other Poultry, within the limits of this Corporation, and whereas authority is given to Municipal Corporations, by Section 360, chap. 54, Consolidated Statutes of Upper Canada, to enact By-Laws for that purpose,

Be it enacted by the Corporation of the Township of Scarboro', that from and after the passing of this By-Law, it shall not be lawful for any person to allow or permit any Geese, Turkeys, or other

Poultry, to trespass or run in any garden, field, or on the premises of any other person.

Be it further enacted, that the owner of all such Geese, Turkeys, or other Poultry, so trespassing or running at large upon the premises of any person, shall be liable to a fine of five cents for each Goose, Turkey, or other Poultry, so found trespassing, irrespective of any damage having or not having been done thereby; and the owner of such Goose, Turkey, or other Poultry, shall be liable for the fine and any damage that may have been done, as well as the costs of collecting, which may be recovered in a summary manner before any one Justice of the Peace, having jurisdiction in the said Township, on the oath of one credible witness, by distress and sale of the goods and chattels of the owner of such Poultry; And in default of sufficient distress, then imprisonment for a term of not less than three days or more than twenty days in the County Gaol; and in case no owner can be found for the Poultry trespassing, for the space of twenty days, they may be sold by the person on whose premises they are found trespassing, to defray the expense incurred, and if any surplus remains it shall be paid over to the Treasurer of the Municipality for the public use of the Township.

And be it further enacted, that all fines levied under the authority of this By-Law, shall be paid by the Justice levying the same to the Treasurer of the Township, to and for the public uses thereof.

Mr. Helliwell, seconded by Mr. Brown, moved, that the case of Robt. Gibson do lay over until the next meeting of Council, and in the meantime the Reeve do make enquiry respecting the admission of patients to the general Hospital. Carried.

Presented by Mr. Snider, petition of Wm. Watson and others, praying for a grant of \$40 to build a bridge between lots 30 and 31, concession D.

Mr. Snider, seconded by Mr. Brown, moved, that the sum of \$40 be granted to build a bridge between lots 30 and 31, concession D, and that Robt. Lovless, David Martin, and Henry Hough, be commissioners to expend the same. Carried.

My Dear Sir,—In a few weeks, perhaps sooner, the arms, accoutrements, great coats, and uniform of the Scarboro' Volunteer Rifle Company will be in our possession; the arms, and accoutrements and clothing, will be worth at least sixty dollars a man—therefore, for only fifty men will be worth £750; but the companies are all to be raised to the full compliment, namely, 75 privates, 3 coporals, and 3 sergeants, in all 81; in this case the property would be worth \$4860; bonds and securities have to be given for the safe-keeping and preservation of these things. I need not say that I have spent considerable money, and a large amount of time and trouble, in getting the company to its present position; may I then respectfully ask the Corporation to give us that countenance, and such a measure of pecuniary assistance as may seem just and proper. Mr. William Johnston is willing to let us have a part of his large room for the

storage of the arms and clothing, at a nominal rent; but arm racks and lockers for the safe-keeping of the rifles and accoutrements have to be made. An insurance must be effected on the property to guard against accident by fire, and many contingent expenses have to be incurred. The Company, as a body, cannot be expected to do anything more than give their time; all the expenses have hitherto fallen upon me, for which I have not, nor shall ever have, one penny reimbursement; the officers have not one penny pay in any shape. I think, therefore, that the community generally should and would be willing to do something for us. I may remark, the arms, &c. are stamped with the name of the Company, and are therefore so far Coporation property. Will you kindly speak to the other members of the Council, and if you think they would make us a small grant, I will make a formal application.




