MINUTES OF COUNCIL.

FIRST MEETING

Of Scarboro' Council, held, pursuant to Statute, on the third Monday in January, 1860, at noon.

The Clerk produced the returns of the elections for the five Wards of the Township, and declared the names of the persons elected members of the Council for the current year—to wit:

James Palmer, Esq.....	Ward No. 1.
William Helliwell, Esq.....	“ No. 2.
John Crawford, Esq.....	“ No. 3.
John P. Wheler, Esq.....	“ No. 4.
Edwin Snider, Esq.....	“ No. 5.

The several members elect having taken the oaths of qualification and of office, the following motion was put and carried.

The Clerk presiding.

Mr. Snider, seconded by Mr. Crawford, moved, that John P. Wheler, Esq., be elected Town Reeve for the current year. Carried unanimously.

Mr. Wheler, having been declared duly elected Town Reeve for the year 1860, and having taken the oath of office as such, addressed the Council.

The Clerk then vacated the chair, and the Reeve took the same.

Mr. Snider, seconded by Mr. Palmer, moved, that John Crawford, Esq., be elected Deputy Reeve for the year 1860. Carried.

Mr. Crawford was declared duly elected Deputy Reeve for the current year, and took the oath of office as such.

The Council then organized and proceeded to business.

The Reeve moved for leave to present the petition of Matthew Percy and others, praying for aid for the Widow Parsons. Petition read and laid on the table.

Application from Joseph Cocksworth, asking for the transfer of the tavern license from Thomas Walls, known by the name of the Alma Inn.

Presented by Mr. Crawford, application from Nathaniel Battrick, asking to be appointed Assessor for the year 1860 :

To the Municipal Council of the Township of Scarboro', in Council assembled :

GENTLEMEN,—I again tender my services as Assessor for the ensuing year. Should your honorable Council think proper to appoint the applicant to the office he solicits, he feels confident of being able to make a perfect Roll. The inaccuracy complained of last year occurred in the copying. All of which is humbly submitted by your obedient servant,

Presented by Mr. Helliwell, the petition of John Law, praying to be appointed Assessor for the year 1860 :

To the Municipal Council of the Township of Scarboro', in Council assembled :

The petition of John Law humbly sheweth,—That your petitioner has already filled the office of Township Assessor, and is again desirous to fill the office for the year 1860, and will perform the duties thereof for the sum of sixty dollars.

Report of the Returning Officers of the yeas and nays taken at the Municipal elections, for the building of a Town Hall. Yeas, fifty-seven ; nays, one hundred and forty. Majority, nays, eighty-three.

Mr. Helliwell, seconded by Mr. Crawford, moved, that Thomas Walls be allowed to transfer his tavern license to Joseph Cocksworth. Carried.

Presented by the Reeve, communication from Mr. John Helliwell, Solicitor, Toronto, together with his account for the sum of nine dollars.

On the question for the appointment of Auditors being put, it was moved by Mr. Crawford, seconded by Mr. Helliwell, that Christopher Thomson be appointed Auditor for the year 1860. Carried.

James A. Thomson was then appointed by the Reeve, pursuant to statute, to the office of Auditor for the current year.

Verbal application by Daniel Ferguson, to be appointed Assessor for the current year.

Mr. Snider, seconded by Mr. Palmer, moved, that Daniel Ferguson be appointed Assessor for the year 1860, at a salary of sixty dollars.

Moved in amendment by Mr. Helliwell, seconded by Mr. Crawford, that as three applicants for the office of Assessor are present, the person that will do the service for the smallest sum, be appointed, and if it is not done correctly to receive no pay for it: upon which the yeas and nays were taken.

Yeas—Mr. Crawford and Mr. Helliwell. Nays—Mr. Snider and Mr. Palmer.

The Reeve voting in the negative, the motion was lost.

The original motion was then put, upon which the yeas and nays were taken.

Yeas—Mr. Snider and Mr. Palmer. Nays—Mr. Crawford and Mr. Helliwell.

The Reeve voting in the affirmative, the motion was carried, and Mr. Ferguson duly appointed Assessor for the current year.

Mr. Crawford, seconded by Mr. Snider, moved, that the account of John Helliwell, Solicitor, for the sum of nine dollars, be paid by the Treasurer. Carried.

Mr. Helliwell, seconded by Mr. Crawford, moved, that the sum of the price of a barrel of flour be given to the Widow Parsons. Carried.

Mr. Helliwell, seconded by Mr. Snider, moved, that the sum of two dollars be granted to Maria Brown, through the hands of John Irving, and that the Reeve give an order on the Treasurer for the same. Carried.

BY-LAW No. 123,

For the Appointment of Auditors, Assessor, and License Inspector.

The Municipal Council of the Township of Scarboro' enacts as follows, That Christopher Thomson and James A. Thomson be appointed Auditors for the current year, at a salary of four dollars each; and that Daniel Ferguson be appointed Assessor, at a salary of sixty dollars; also, that John Malcolm be appointed License Inspector for the current year, at a salary of fifteen dollars.

2nd. Be it further enacted, That that part of By-Law No. 95, appointing the salaries of Auditors, Assessor, and License Inspector, be, and the same is hereby repealed.

SECOND MEETING

Of the Scarboro' Council, held, pursuant to adjournment, on Monday, 27th February, 1860, at Mr. J. Armstrong's Inn.

MEMBERS PRESENT.—John P. Wheeler, Esq., *Town Reeve*, John Crawford, Esq., *Deputy Reeve*, Wm. Helliwell, Esq., Edwin Snider, Esq., James Palmer, Esq.

Minutes of preceding meeting read and confirmed.

Presented by the Reeve, petition of Marshall Maclin and others, praying for aid to open road across lots 25 and 26, on the 4th concession line.

To the Municipal Council of the Township of Scarboro', in Council assembled :

GENTLEMEN,—The petition of the undersigned humbly sheweth,—Whereas that part of road lying in front of lots Nos. 25 and 26, on the 4th concession line, being rendered impassable, on account of its

swampy nature, for the greater part of the year, for the want of a covering of earth or some other material, we would respectfully urge the necessity of your honorable body taking the same into your serious consideration, and grant a sum of money to render it passable, as it is a great convenience to the public and to those living in the immediate vicinity, those having business to transact on the 4th having either to go round by the 3rd or 5th concessions. And your petitioners would beg leave further to state, that in their opinion, to make a good and sufficient road, it will require a covering of earth eighty rods in length, twelve feet in width, and ten inches in depth, which your petitioners think cannot be done for a less sum than from one dollar to one dollar and twenty-five cents per rod, as the earth will all have to be drawn on to it. And your petitioners would also beg leave to remind your honorable body that, as there is a large balance standing to the credit of the Township, your petitioners (in the premises) doth pray for speedy relief.

Petition read and laid on the table.

To the Municipal Corporation of Scarboro', in Council assembled :

The petition of Jonathan Baird, Innkeeper, humbly sheweth,—That in the early part of last year (1859) your petitioner had an information laid against him, before the Magistrates within this Municipality, by a notorious character, of the name of Johnson, for contravening, though unintentionally, the Provincial Tavern Laws, on which information your petitioner was convicted and fined five pounds.

That your petitioner, and the public generally, feel satisfied that the information was laid, not with a view of preventing a public nuisance, or of enforcing a due observance of the laws, but, ostensibly, for the purpose of obtaining one half of the fine imposed. That your petitioner has already paid ten dollars to the Magistrates to enable them to pay this notorious character and informer his proportion of the fine. That your petitioner having been called on to pay that part of the fine payable to the Municipality, has requested the Magistrates to allow him time to lay the case before your honorable body, which they have kindly consented to do.

Your petitioner, therefore, prays, that as no loss has been sustained by the Municipality, no nuisance committed on the public, and being the first and only complaint against your petitioner, as Innkeeper, that the Council will be pleased to take his case into their serious consideration, and that they will remit the proportion of the fine payable to the Municipality, and order that the Magistrates do not enforce the same; or otherwise, that the amount may be deducted from the amount of your petitioner's ensuing year's license.

To the Municipal Council of the Township of Scarboro', in Council assembled :

GENTLEMEN,—I beg to report to your honorable body that I have inspected all the Taverns in this Township pursuant to By-Law, and found the following parties, namely, Alexander Moffatt, John Warffe, Ingol Burton, William Marr, John Hockridge, Richard Sylvester, Alexander Thompson, Eli Shackleton, A. Noble, Joseph Armstrong, Jonathan Baird, P. C. Secor, Wm. Burton, Jr., and Joseph Cocksworth, with the necessary accommodation according to the By-Law in that behalf.

The humble petition of Anne Simmons respectfully sheweth,—That your petitioner has for several months past been laboring under chronic

disease, rendering her incapable of maintaining herself and four children. That, whilst acknowledging with gratitude the kind professional services of Dr. Closson, and the assistance rendered her by others, especially J. P. Wheeler, Esq., she humbly prays from your honorable council such assistance as you in your wisdom may deem her situation needs. Your petitioner would respectfully say that the sum of ten dollars would meet her present necessities, and place herself and children in immediate comfort.

Mr. Helliwell, seconded by Mr. Crawford, moved that the sum of five dollars be granted to John Todd, for a plan of Scarboro' Village, and that the Reeve give an order for the same. Carried.

Presented by Mr. Palmer, petition of the several Tavernkeepers in the Township of Scarboro', praying for a reduction on their license.

To the Municipal Corporation of Scarboro', in Council assembled:

The petition of the undersigned respectfully sheweth,—That your petitioners respectfully beg to state to your honorable body, that they consider the present rate of duty payable on tavern licenses very high and disproportionate, when compared with the reduction of business heretofore done by tavernkeepers. Your petitioners would likewise respectfully state, that, previous to the construction of railroads through the Province, the travel and the produce and merchandize of the country was conveyed on the roads of the several Townships, which conferred a benefit on tavernkeepers generally, throughout the Province, at which time your petitioners felt satisfied, and cheerfully paid the amount fixed as tavern license. Your petitioners would also respectfully call

the attention of your honorable body to the reduction experienced in their business, by the scarcity of money so generally felt, and the want of employment amongst mechanics, tradesmen and the laboring classes of society; all of which tends to lessen the business of tavern-keepers.

Your petitioners would also respectfully state, that they have understood from good authority, that the Municipality of Markham have in their wisdom taken these circumstances into their consideration, and have reduced the amount of tavern license within their jurisdiction to twenty-five dollars each. Your petitioners, therefore, pray that your honorable body will be pleased to receive this their petition, and grant them such relief, by reducing the amount of duty on tavern license, as in your wisdom will appear just and reasonable.

Memorial laid before the Council by the Foreman of the Coroner's Jury in the case of the late Charles Ham :

To the Reeve and Council of the Township of Scarboro', in Council assembled.

The memorial of the undersigned humbly sheweth,—That your memorialists were called upon, in the capacity of a Coroner's Jury, some time since, to enquire into the cause of the death of Charles Ham, late of the Township of Pickering, County of Ontario. That our finding was unanimous, that the death of said Ham resulted from collision of an engine or train running eastward upon the Grand Trunk Railway, as said Ham was passing the Kingston Road crossing, in the Township of Scarboro'. That the evidence adduced upon the inquest led also to unanimity of opinion with the Jury, that very great neglect of duty prevails on the part of specials who have charge of trains upon said railway, and that the signals of approach to crossings, required by law, is often neglected, to the very great danger of travellers both upon the railway as well as upon the highway. That we would desire to bring before your notice, and through you, as the representatives of the people of Scarboro', before the notice of the Grand Trunk Railway, the peculiarly dangerous character of the crossing alluded to.

We have the most of us had occasion to pass said crossing frequently, and beg to state that, from the physical character of the adjacent grounds, we cannot at any time feel ourselves able to pass said crossing in safety. This fact, connected with the well-known neglect of engine drivers, must, we hope, suggest to the railway authorities that some effectual precaution should at once be taken to prevent the recurrence of accident and secure the safety of the travelling public.

Your memorialists, therefore, pray that the foregoing facts will secure such attention at your hands as their importance seems to demand.


