MINUTES OF COUNCIL.

FIRST MEETING.

In accordance with the Statute, 22nd Vict., cap. 54, section 130, the Councillors elect met this sixteenth day of January, 1865, at noon, at Johnston's Inn, Woburn.

The Clerk produced the Poll Books of the different Returning Officers, with their solemn declarations thereunto annexed, declaring the following named gentlemen duly elected Councillors for each ward respectively in this Municipality, for 1865, who, having made and subscribed to the declaration of qualification and of office, according to law, took their seats as follows, viz.:—

The Clerk in the chair.

Mr. Tabor, seconded by Mr. Chester, moved, that D. G. Stephenson be elected Township Reeve for the current year. Carried.

Yeas—Messrs. Tabor, Chester and Stephenson.

Nays—Messrs. Wheeler and Clark.

Mr. Stephenson having made and subscribed the declaration of office according to law, took his seat as Reeve.

Mr. Wheeler, seconded by Mr. Clark, moved, that William Clark be elected Deputy Reeve for the current year. Lost.

Yeas—Messrs. Wheeler and Clark.

Nays—Messrs. Tabor, Chester, and the Reeve.

Mr. Tabor, seconded by Mr. Chester, moved, that George Chester be elected Deputy Reeve for the current year. Carried.

Yeas—Messrs. Chester, Tabor, and the Reeve.

Nays—Messrs. Clark and Wheler.

Mr. Chester having made and subscribed the declaration of office according to law, the Council proceeded to business.

Mr. Wheler, seconded by Mr. Clark, moved, that James A. Thomson be and is hereby appointed one of the Auditors for the current year. Lost.

Yeas—Messrs. Clark and Wheler.

Nays—Messrs. Chester, Tabor, and the Reeve.

Communications read and laid on the table :—

From H. Seymour Hubertus, Deputy Clerk of the Peace, York and Peel, calling strict attention to the Upper Canada Jurors' Act, in preparing the Jury Lists for 1865.

From George Murray, Secretary to the McKenzie Homestead Committee, soliciting the Council to inaugurate the collection of subscriptions, so that the claim of Messrs. Taylor, for paper, may be paid, and the Homestead preserved to Mrs. McKenzie.

Presented by Mr. Chester, the petition of the Trustees of School Section No. 6 :—

To the Municipal Council of the Township of Scarborough :

Mr. Wheler, seconded by Mr. Clark, moved, that James A. Thomson be and is hereby appointed Inspector of Houses of Public Entertainment for the current year, at a salary of fifteen dollars. Lost.

Mr. J. P. Wheler, seconded by Mr. Clark, moved, that Daniel Ferguson be and is hereby appointed Assessor for the current year, at a salary of seventy dollars. Carried.

Mr. John Tabor, seconded by Mr. Chester, moved, that James Ormerod be and is hereby appointed Inspector of Houses of Public Entertainment for the current year, at a salary of fifteen dollars. Carried.

Mr. Chester, seconded by Mr. Wheler, moved, that the petition of John Irving and others, for the relief of Charles Champaign, be granted, and that the Treasurer be and is hereby authorized to pay to John Irving, for the relief of the said Charles Champaign, the sum of eight dollars. Carried.

Mr. Wheeler moved for leave to introduce a By-Law for the appointment of Auditors, Assessor, and Inspector of Houses of Public Entertainment. Leave given.

By-Law read a first and second time.

On motion of Mr. Wheeler, the Council went into Committee of the Whole thereon.

Mr. Clark in the chair.

The committee rose, and reported the By-Law as amended. Report received and adopted. By-Law read a third time and passed.

BY-LAW No. 164,

For the appointment of Auditors, Assessor, and Inspector of Houses of Public Entertainment.

1. *Be it enacted*, by the Corporation of the Township of Scarboro', that William Dickson and William Shirrefs be and are hereby appointed Auditors, at a salary of four dollars each per annum.

2. *Be it further enacted*, that Daniel Ferguson be and is hereby appointed Assessor for the current year, at a salary of seventy dollars per annum.

3. *And be it further enacted*, that James Ormerod be and is hereby appointed Inspector of Houses of Public Entertainment for the current year, at a salary of fifteen dollars per annum.

Mr. Clark, seconded by Mr. Wheeler, moved, that the Reeve be authorized to inform the Steward of the Toronto General Hospital that this Municipality will pay for the maintenance of Robert Hacket, at the rate of twenty-five cents per day, until he may become entitled to be placed on the free list; said Robert Hacket being in destitute circumstances, and having been placed in the Hospital by Mr. Henry Mason. Carried.

Mr. Wheeler, seconded by Mr. Clark, moved, that this Council do now adjourn, to meet again on the third Monday in February next, at this place. Carried.

SECOND MEETING.

MONDAY, February 20th, 1865.

The second meeting of the Corporation of the Township of Scarboro', was held, pursuant to adjournment, on February 20th, at Mr. Johnston's Inn.

Minutes of last meeting read.

The Reeve laid on the table the following communications, which were read:

MILITIA DEPARTMENT,

ADJUTANT GENERAL'S OFFICE,

Quebec, 19th January, 1865.

SIR,—I beg to request that you will call the attention of the Assessors of the Municipality, in taking the Annual Assess-

ment, to the requirements of the 6th section of the Militia Act of 1863, particularly with respect to the filling up correctly the three additional columns required, with the names and residences of first and second class service-men and reserve-men, respectively.

By reference to sub-section 1 of section 25, it will be seen that the Battalion Rolls of the Ballot of the Service Militia must be defective if the Municipal Rolls, from which the County Rolls are prepared, do not show in the proper columns the class to which the parties respectively belong, or if the residences are not specially designated by "lot, concession or range, &c."

Presented by Mr. Chester, the petition from William Burton, Sen., and thirty-two others, praying that a certificate to obtain a Tavern License be granted to William Burton, Jr., to keep an Inn at Malvern, on lot No. 19, concession 2nd, and known as *Speed the Plough Inn*.

Presented by Mr. Tabor, the petition from Septimus Auburn and thirty-two others, praying that a certificate to obtain a Tavern License be granted to Ingol Burton to keep an Inn on lot No. 29, concession B, and known as the *Farmers' Inn*.

Presented by Mr. Tabor, the petition from Septimus Auburn and thirty-six others, praying that a certificate be granted to Alexander Thompson to obtain a Tavern License to keep an Inn on lot No. 27, concession B, and known as the *Halfway House*.

Presented by Mr. Tabor, the petition from Lawrence Brannen and thirty others, praying that a certificate be granted to Nelson Gates, to obtain a Tavern License to keep an Inn on lot No. 20, concession C, and known as the *Scarboro' Inn*.

A verbal application was made to the Council by Messrs. J. McCowan and T. Brown, for aid to John Hay, an infirm old man in destitute circumstances; who has no fixed place of abode, but has been wandering through this and the neighbouring Townships for a number of years, and who is now sick at Malvern, at the house of Mrs. Malcom.

Mr. Wheler, seconded by Mr. Chester, moved, that the Treasurer be and is hereby authorized to pay to Rose Ann Purdy the sum of one dollar per week for board of the foundling child placed in her keeping by the Council, said payments to commence from the 15th February inst., and that the resolution passed on the 19th January, 1863, in reference to said child, be and is hereby rescinded. Carried.

Mr. Wheler, seconded by Mr. Clark, moved, that the Treasurer be and is hereby authorized to pay to Rose Ann Purdy the sum of fourteen shillings and eleven pence, for clothing furnished for a foundling child placed in her keeping by the Council. Carried.

Mr. Wheler, seconded by Mr. Chester, moved, that the Treasurer be and is hereby authorized to pay to the order of Messrs. T. Brown and J. McCowan the sum of twenty dollars, to assist in paying the expenses of John Hay, a destitute old man, from this place to his native country, Scotland, he having signified his desire to return there. Carried.

Mr. Chester, seconded by Mr. Tabor, moved, that the sum of six dollars be granted for the relief of Elizabeth West, and that the Treasurer be and is hereby authorized to pay the same to the order of the Councillor for Ward No. 3. Carried.

Mr. Wheler, seconded by Mr. Chester, moved, that Smith Thompson's bill, amounting to six dollars, and also the bill of Thomas Stephenson, amounting to two dollars and fifty cents, be paid on order of the Reeve. Carried.

Mr. Tabor, seconded by Mr. Clark, moved, that the following persons, petitioners for certificates for Tavern Licenses, are entitled to certificates for such Licenses, and that the Treasurer of this Municipality be directed to issue said certificates on the payment of thirty-three dollars for each certificate so granted; that is to say, viz.:

Eli Shackleton, Richard Sylvester, Wm. Johnston, Jonathan Baird, Ingol Burton, Alexander Moffat, Alexander Thompson, Samuel Mighton, and William Burton. Carried.

Mr. Chester, seconded by Mr. Wheler, moved, that a committee be appointed for the purpose of examining and reporting to this Council as to the state of two Bridges, situated on the first concession, opposite lots Nos. 14 and 15 respectively, as to the amount of expenditure necessary for the building and repairs of said Bridges, and that Messrs. Wheler, Stephenson, and the mover, be a committee for said purpose. Carried.

Mr. Wheler, seconded by Mr. Chester, moved, that the Council do now adjourn, to meet again on the first Monday in March next. Carried.

THIRD MEETING.

MONDAY, 6th March, 1865.

Council met this 6th day of March, at Johnston's Inn.

MEMBERS PRESENT.—Donald G. Stephenson, Esq., *Reeve*; George Chester, Esq., *Deputy Reeve*; William Clark, Esq., John Tabor, Esq., and John P. Wheeler, Esq.

The Reeve in the chair.

Minutes of last meeting read.

The Reeve read and laid on the table the following communications and accounts :

From the *Globe* office, for printing and advertising in *Globe* notice to Parliament and By-Law No. 163, and that vote will be taken thereon.

From M. C. Cameron, in reference for bill to establish F. F. Passmore's survey.

From Auditors' Report on Township Accounts for 1864, with abstracts.

From James Ormerod, Inspector, Report of Inspection of Inn at Highland Creek, known as the *Commercial Inn*.

From J. Crawford, Treasurer, bonds.

From William Clark, requesting the Council to pay the allowance he receives for support to the order of Wm. Tredway, instead of Mrs. S. A. Clark, as formerly.

From John Irving, for paper and pens supplied to James Moyle, late clerk.

Petitions presented :

Presented by Mr. Tabor, the petition of William Muir and thirty-five others, praying that a certificate to obtain a Tavern License be granted to William Keeler, to keep an Inn on lot No. 7, con. 1, and known as the *Commercial Inn*.

Presented by the Reeve, the petition from Jeremiah Annis and twenty-one others, praying the Council to grant aid to Frederick Ellis,

Presented by Mr. Stephenson, the petition of Jas. Humphrey and thirty-seven others, praying the Council not to memorialize the Legislature to confirm F. F. Passmore's survey.

Mr. Tabor, seconded by Mr. Clark, moved, that the Treasurer do issue the necessary certificate, on the payment of thirty-three dollars, to enable William Keeler to obtain a Tavern License. Carried.

Mr. Tabor, seconded by Mr. Clark, moved, that the Treasurer be and is hereby authorized to pay to the order of Mr. Chester, twenty dollars, to be applied for the relief of John Hay, an indigent person, and that the resolution passed at the last meeting, referring to the relief of the said John Hay, be and is hereby rescinded. Carried.

Mr. Wheler, seconded by Mr. Chester, moved, that the allowance of one dollar per week for the support of Wm. Clark be paid to William Tredway, on order of the Reeve, to be expended by him for the maintenance of Wm. Clark, payment to commence from the 20th February last, and that all former resolutions passed relative to said Clark's support be rescinded. Carried.

Mr. Tabor, seconded by Mr. Clark, moved, that the Treasurer do pay the sum of seventy cents to Mr. J. Irving, in discharge of his account, submitted to the Council this day. Carried.

Mr. Wheler, seconded by Mr. Clark, moved, that the Treasurer's bonds, just read, be received and adopted, and that it be deposited with the Reeve for safe keeping for the Municipality. Carried.

Mr. Tabor, seconded by Mr. Clark, moved, that the Treasurer do pay to Frederick Ellis, on the order of the Reeve, for the relief of the said Frederick Ellis, the sum of ten dollars. Carried.

Mr. Chester, seconded by Mr. Wheler, moved, that the Treasurer be and he is authorized to purchase a city of Toronto Debenture with the uninvested clergy reserve funds now in his hands, at as low a rate as practicable. Carried.

Mr. Wheler, seconded by Mr. Clark, moved, that the two bills for advertising in the *Globe* newspaper, amounting to

thirty-four dollars and ninety cents, be paid by the Treasurer.
Carried.

Mr. Tabor, seconded by Mr. Chester, moved, that in consequence of many reasonable protests having been submitted to this Council by several landholders of this Municipality, relative to the survey of Mr. Passmore, affirming its incorrectness, it is just and expedient to suspend all action on the part of this Council for the present, having for its object a requisition upon the Provincial Legislature to confirm said survey. Carried.

Yeas—Messrs. Tabor, Chester, and the Reeve.

Nays—Messrs. Wheler and Clark.

Mr. Wheler, seconded by Mr. Clark, moved, that the Treasurer's Account for the year 1864, as now presented, together with the Auditor's Abstract and Report, be finally adopted, and that the Clerk is hereby authorized to get the same published forthwith, with the Minutes of the Council for the year 1864, at as cheap a rate as possible, and that the number be 500.
Carried.

Mr. Chester, seconded by Mr. Wheler, moved, that this Council do now adjourn until the third Monday in April next.

Council met this day, pursuant to adjournment, at Johnston's Inn.

Minutes of last meeting read.

Presented by Mr. Chester, the petition of Wm. J. Fawcett and thirteen others, praying the Council to build a bridge over the Highland Creek and repair the hills in front of lots Nos. 14 and 15, in the 1st concession.

Presented by the Reeve, the account of George Bambridge, of two dollars and fifty cents (\$2 50), for cutting threads and making nuts for two iron bolts for the bridge over the Little Rouge, in the fourth concession, between lots Nos. 4 and 5, in the year 1864.

Mr. Tabor, seconded by Mr. Clark, moved, that the sum of forty dollars be appropriated out of the general funds of the Municipality of Scarborough for the purpose of repairing a culvert opposite concession D, on the town-line between York and Scarborough, with a proviso, that an equal sum be granted for such purpose by the Council of the Municipality of York, and that Mr. James McCowan and Mr. John Walton, Sen., be appointed commissioners to expend the same on behalf of this Council, and that the Clerk be requested to notify the Reeve of York of such resolution. Carried.

Mr. Tabor, seconded by Mr. Clark, moved, that the sum of forty dollars, appropriated for the repair of a culvert on the town-line between York and Scarboro', as passed by the Council this day, be paid by the Treasurer, upon the order of the Councillor of Ward No. 5. Carried.

Mr. Wheler, seconded by Mr. Clark, moved, that the Clerk be and is hereby authorized to give immediate notice to all parties occupying any portion of any side road-allowance, as

indicated by the survey made by Mr. Passmore, P.L.S., under the authority of Acts 24 Vic., cap. 64, and 25 Vic., cap. 38, to remove all obstructions from off the said side-road allowances within eight days from date of notice; and in case any parties refuse to comply with such notice, and obstruct the public highway so as to prevent the public from travelling thereon, that the Reeve do take legal proceedings to enforce the same. Carried.

Mr. Wheler, seconded by Mr. Tabor, moved, that the bill presented by Mr. Bambridge, amounting to two dollars and fifty cents (\$2 50), for cutting threads and making nuts on bolts for bridge, be paid on order of Reeve. Carried.

Mr. Tabor, seconded by Mr. Clark, moved, that the sum of ten dollars be and is hereby granted to John C. Jones, an indigent person, to be paid by the Treasurer to the wife of the said John C. Jones. Carried.

Mr. Chester, seconded by Mr. Clark, moved, that the sum of four dollars be and is hereby granted for the relief of Chas. Masterman, and that the Clerk be authorized to pay the same, on order of the Reeve. Carried.

Mr. Wheler, seconded by Mr. Clark, moved, that the Treasurer be and is hereby authorized to take from Messrs. To the Council of the Corporation of the Township of Scarborough :

The Report of the Select Committee appointed to examine the condition of the bridge passing over the river Rouge, on lot No. 5, in the 3rd concession of the Township of Scarborough, and to report the result of said examination to the said Council, at its meeting to be held on the 29th May, 1865 :

1st. Your committee beg leave to report as follows: That in discharge of their duty they met at the bridge named in their commission, on Saturday afternoon, the 27th May, 1865, and on close inspection found said bridge in a state of great dilapidation, so much so as to render it exceedingly dangerous for a loaded team to pass over the same.

2nd. Your committee observed said bridge to be composed entirely of timber, put together in the form of tressels, or bents, extending over a distance of 230 feet, or thereabouts. The part of said bridge immediately spanning the river is in a tolerable state of repair, having been repaired within the last few years. Such portion covers a distance of about 50 feet. The residue of said bridge, measuring something over 180 feet, extends from the north side of the river, over a ravine or valley, together with a small creek, to the northerly bank of said ravine, thus making the entire bridge. This portion of the bridge is in a most shattered state, owing to most of the mud sills, many of the post-girts, braces, string-pieces, planks, (indeed most all of the planks) being in a completely rotten condition, so as to be entirely worthless for any purpose whatever. A great many of the braces which constitute the principal support of the structure, are not in their places. Many of the posts are now much out of perpendicular—a circumstance caused by the decay of the mud sills, posts, girts, and braces, and therefore may at any time, under any sudden impulse, entirely give way. Such a state of things must obviously necessitate immediate reparation or reconstruction.

3. Your Committee would respectfully suggest that to repair after the mode employed in the present structure, would be a waste of money, and attended by heavy expenditure to be repeated at short intervals, with no permanent effect.

Your Committee would therefore advise in the matter the following course:—First, that the portion of the present bridge, immediately spanning the river, be allowed to remain undisturbed for the present, as with a little, almost inexpensive adjustment, it may serve a useful purpose for some time to come.

4. Your Committee would also recommend that a competent person be employed by the Council to form a plan and specifications, necessary to the repair of said bridge; and that the sum of four hundred dollars be appropriated by your Council, for the purpose of repairing the same, to be expended by Messrs. John Coxworth, William Helliwell, and Stephen Closson, commissioners for that purpose.

All of which is respectfully submitted.

Mr. Tabor, seconded by Mr. Chester, moved, that the Reeve, together with Mr. Chester, be and are hereby authorized and appointed by this Council to consult counsel learned in the law with reference to the validity of a certain mortgage held by the Municipality of Scarborough against the west half of lot No. 12, in the ninth concession of Markham, with especial regard to the following points;—1st. As legality of said mortgage, as involving the action and duty of the corporation therein in a legal point of view. 2nd. As regards the extent of the indemnity afforded the municipality by the statute of 1863; and furthermore, that after consultation had, the said parties, as above commissioned, do and shall report to this Council as early as possible the result of their consultation. Carried.

Mr. Wheler asked for leave to bring in a By-law to appoint Returning Officers for 1866, and places for holding the municipal elections. Leave given.

By-law introduced, and read the first and second time ; and the Council went into Committee of the whole thereon.

TWELFTH MEETING.

From Messrs. Paterson, Harrison & Paterson, legal opinions regarding a road through Mr. Gorrie's place, lot No. 5, con. 3, Scarboro', and also an opinion on a mortgage held by this Corporation against Edward Wheler, of the west half of lot No. 12, in the ninth concession of Markham. They read as follows.

DEAR SIR,

In reference to the question submitted to us, under your direction, by Mr. Closson, one of the commissioners appointed by the township council for expending certain moneys in repair of roads, &c., we have examined the deed of Messrs Eaton & Peters to the township and accompanying plan. When Mr. Closson spoke to us on the subject, we were under the impression that Mr. Gorrie, the present possessor of lot No. 5, in the 3rd concession, had acquired his title from Mr. Eaton *subsequently* to the deed from Mr. Eaton to the corporation; and Mr. Closson was also under that impression. We have since made a search at the Registry Office, and find that the mortgage from Eaton to Gorrie, and under which partially his title is derived, bears date a few weeks *prior* to the deed from Eaton to the township, and was duly registered, and that neither it nor the deed of release of the equity of redemption afterwards obtained by Mr. Gorrie from Eaton's assigns, makes any reservation or mention of the road. Under these circumstances, we fear that the deed to the municipal corporation would not be held a good grant as against Gorrie's title, but that the character of the road as a highway would have to be established by facts independently of the grant. The Municipal Act (C.S.U.C. ch. 54, sec. 313,) defines what shall be deemed a public highway. It is there provided, amongst other things, that all roads whereon the public money has been expended for opening the same, or whereon the statute labour has been usually performed, shall be deemed common and public highways. We understand that public money was expended, and statute labour usually performed, on this road. We think, therefore, that it must be deemed a highway to the extent and width actually travelled and used as a road; but as it is in parts not enclosed by any fence, and in other parts fenced in only to the width of about twenty feet, we are inclined to the opinion that the right of a public highway could

only be successfully asserted as against Gorrie, to the extent actually enclosed or travelled as a road, and not to the full width contemplated by the grant. The consequence is that, in our opinion, the Municipal Corporation and the contractors for repair of the Rouge bridge on the road would, in strict law, be wrong-doers in taking sand or gravel outside of the fence or the actual line of travelled road where not fenced.

As, however, it seems a matter of great urgency, and even of necessity for the public interests, that the gravel for filling in at the ends of the bridge should be obtained at once, and as it can only be (in accordance with the contract entered into) outside of the limits described in the grant, and as, at the worst, any damages Mr. Gorrie could recover would probably be very trifling, we think it would be well, perhaps, should the Municipal Council think proper, under the circumstances, to proceed with the work as if the grant of the road were in all respects valid, even at the risk of being subjected to a small measure of damages. And we would advise the Council without delay to take the necessary steps under the Municipal Act, to have the road, as described in the grant, established by By-Law as a public highway, and so remove any question on the subject in future.

DEAR SIR,

We have examined the mortgage from Edward Wheler and wife to the Corporation of the Township of Scarborough, dated 4th February, 1857, securing the sum of £825, loaned to Mr. Wheler by the Township out of moneys derived from "The Upper Canada Municipalities Fund." We understand that no By-Law was passed by the Township relative to these moneys, but that they have been all along set apart and appro-

priated for educational purposes by the Township Council according to the Clergy Reserve Act (C.S.C. ch. 25, sec. 11), we think a by-law should have been passed defining the purpose for which these moneys and the proceeds from investments should be applied, and then the investments should have been made in the purchase of debentures mentioned in the act, and not by mortgage on real estate. And we are inclined to think that, for these reasons, the members of the council who authorized this loan would be liable to the corporation for any loss that might arise from insufficiency of the security. But we are not prepared to say that the mortgage would have been held, even under the act of the Consolidated Statutes, invalid; on the contrary, we think that, at all events, the covenant for the payment of the money could have been enforced by action against Wheler, and possibly the security on the land also, though considerable doubt may exist on this latter point. However that may be, we are strongly of opinion that the mortgage is made valid by the Act of 1863, ch. 17, s. 2. This act seems to contemplate that when mortgages mature, the money should be invested in other like securities. As the mortgage in question is now past due, and as Mr. Wheler seems unable or unwilling to pay, and as the sum is large to be outstanding on the security of one hundred acres of land, we would advise the Council to take steps without delay to have the amount realized, by a bill in Chancery for a sale of the lands.

The Act of 1863 requires that the moneys for the Upper Canada Municipalities Fund should be set apart by by-law. As this has not been done by your corporation (though we understand that it has been set apart and appropriated by *resolution* of the council). We would also advise that a by-law be at once passed reciting the purpose for which these moneys have been set apart, and defining the purposes for which the moneys and their proceeds are to be continued to be held and appropriated in accordance with the act.

Mr. Tabor, seconded by Mr. Chester, moved, that in consequence of various sources of embarrassment presenting themselves to this Council, as regards the improvement of what is commonly called the Markham and Port Union road, in the Township of Scarborough, it is expedient and feasible, under the circumstances, that another line of road be adopted, more especially harmonizing with the interests of this Municipality, and that, in pursuance of this object, Messrs. Wheler, Stephenson, and Chester, be a committee to report to this Council, at its next meeting, the results of their investigation of this subject, and they are hereby authorized to make such exploration as to them may seem necessary to effect so desirable an end.

Mr. Wheler, seconded by Mr. Clark, moved in amendment, that, whereas a portion of the side road allowance between lots Nos. 4 and 5, third concession, is considered impracticable as a public highway, and it is deemed necessary for the public good to open up a new road in lieu thereof,

Be it therefore Resolved, That the Reeve be, and is hereby authorized to employ a competent provincial land surveyor to examine the ground, and select the best and most convenient location for a new line of road, with a view of having the same established in accordance with the Municipal Act of U. C. Carried.

Nay—Mr. Tabor.

Mr. Tabor, seconded by Mr. Chester, moved, that the head of this Council be and is hereby instructed, authorized and empowered, to take such steps (immediately) as may be deemed strictly requisite, to recover and collect all moneys due to this Municipality, under and by virtue of a certain indenture of mortgage held by this Municipality against the westerly half of lot number twelve, in the ninth concession of Markham. And furthermore, to report to this Council at its next meeting all such proceedings, and the results thereof, as shall have been taken and arrived at in prosecution of the duties enjoined by this resolution.

Mr. Clark, seconded by Mr. Wheler, moved in amendment, that the Clerk be instructed to intimate to Mr. E. Wheler that he will be required to pay the mortgage that this Municipality holds on his property on or before the 4th of February, 1866. Lost.
