Below will be found the dates for this season's events. By hanging this WEEKLY on a handy nail, you will have the dates of the masquerades and be able to make your arrangements accordingly.

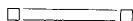

## EDITORIAL

### WHY BONFIRES ON BEACH FORBIDDEN

We sometimes wonder why we are not permitted by law to build bonfires on our beach, but when it is pointed out that there are dangers other than that of causing fire loss to property, we should study the situation.

Only the other day our attention

was directed to one uncomfortable and painful instance.

It seems that a party of bathers had gone to the beach between 10 and 11 o'clock at night. A small fire was built—not for providing heat—but to make the beach a bit cheerier after the swim. After lolling around for a while in the fire-light the bunch started back to the tent, extinguishing the fire before leaving, by covering the coals with sand.

Some girl swimmers happened to be walking along shortly after and stopped at the same spot where the previous party had made their fire. It was a nice spot on the beach.

As the girls prepared for their midnight dip, one of them gave a loud cry. She had stepped on the sand covered fire, and had seriously burnt one of her feet.

The next day the City Council issued a warning that fires must not be built on this or any other beach within the City limits.

We don't need beach "Glows." Let's do our bit to stop them—then we'll be safe from danger, protect our friends and be well within the law.

## ECHOES FROM EDEN

Your President appreciates the kindness of Mr. Dennison, President, Island Aquatic Association, for his kind invitation to the Summer Regatta held last Saturday on Long Pond. While we found it impossible to accept, it is indeed pleasant to know that the W.I.A. was remembered by our neighbors.

The Editor of the WEEKLY has kindly consented to print the report of the Constitution Committee. This Committee, as you will remember, was appointed at last year's General Meeting to consider and report on a revision of the W. I. A. Constitution. The report

does not change to any great extent our present constitution, but to know that due consideration was given to each and every clause is, I am sure, appreciated by all members of our Association. I would therefore suggest that each member read over the report and thereby be in a better position to discuss the question at the Special Meeting called for Monday, July 25, at 8.45 P.M.

We note that this date is the night of the Ladies Bowling. May we ask for the co-operation of the Ladies in arranging to play their games earlier or call the game at 8.45 sharp.

What a good old spot Ward's Island is and how generous the people. The Association has already handed Freddie Bennett \$200.00 with the best wishes of Ward's Islanders. Now the Ladies are working for the kiddies and will be able to turn over to the Star Fresh Air Fund a goodly sum. And then again the Ladies and the Executive's Special Committee are planning one great day for Civic Holiday to raise funds to wipe out last year's deficit.

We are indeed grateful to the Parks Commissioner, Mr. C. E. Chambers, for his attention to our requirements. The lighting in the lavatories is fine and so is the provision for rinsing out pails, but we would suggest that a somewhat better provision would be the installing of a 12" to 6" reducer connected with a 6" trap to the cesspool and having a tap about 2 feet above the 12" top. This would answer the purpose for emptying and rinsing and save all the inconvenience caused by the Toilets becoming plugged.

The extra benches and tables are much needed. Mr. McBride assisted us in getting them and we appreciate his good work. Thanks, Mr. Chambers, but what about moving the fire hydrant from centre field. This hydrant is in a very dangerous position. To move it close to the sidewalk would increase its efficiency in case of a fire on Willow or Withrow.

An ounce of prevention is worth a pound of cure.

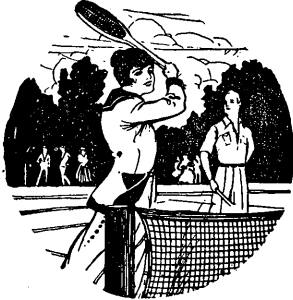

## Constitution Ward's Island Association.

**1. Association.** The association shall be called, "Ward's Island Association."

**2. Location.** The home of the association shall be that portion of the island of Toronto beginning at the west end of lot No. 1 being that lot lying immediately west of house No. 166 Lake Shore Avenue, and extending east to the westerly pier of the channel at the easterly end of the island.

**3. Objects.** To provide the members thereof with suitable accommodation, means and appliances for the pursuit and promotion of aquatic and other amateur sports or pastimes, and to promote the general interests of the residents of Ward's Island.

**4. Membership.** There shall be four classes of membership, viz., Senior, Intermediate, Junior, Privileged.

**Section A.** Senior membership shall consist of members eighteen years of age and under, residents of Ward's Island, who shall be entitled to all the privileges of the association.

**Section B.** Intermediate membership shall consist of members, fifteen, sixteen and seventeen years of age, residents of Ward's Island, who shall be entitled to all the privileges of the association.

**Section C.** Junior membership shall consist of members fourteen years of age and under, residents of Ward's Island who shall be entitled to all the privileges of the association except the right to vote.

**Section D.** All members in section A, B and C shall be bona fide residents of Ward's Island for a period of at least thirty days prior to August fifteenth.

**Section E.** Privileged membership. Temporary residents of Ward's Island or visitors may become privileged members on payment of the regular fee. As such they shall be entitled to all privileges of the Association excepting the right to vote or to participate in the Annual Aquatic or field day events.

**5. Propositions for Membership.** Applications for membership shall be made in writing accompanied by the annual fee, and endorsed by a proposer and a seconder, who shall be members of the association in good standing. All applications shall be finally dealt with by the executive committee.

**6. Fees.** The annual fees shall be payable in advance and must be paid not later than the fifteenth of June in each year.

The annual fees shall be as follows:

(A) Senior, gentlemen .....	\$2.00
(B) Senior, ladies .....	.50
(C) Intermediate, boys .....	1.00
(D) Intermediate, girls .....	.50
(E) Junior, boys and girls ..	.25

With reference to clause No. 6—Fees—your committee is of the opinion that the Annual Fees should be fixed at a rate which will place the Association on a self-sustaining basis and recommends that the matter be given the immediate consideration of the Association.

**7. Officers and Committees.** The Executive of the Association shall consist of Hon. Pres. (Retiring President), President, Vice-President, Secretary-Treasurer, and a Committee of eleven members of the Association—two of whom shall be ladies—one representing senior and one representing junior ladies sports.

**8. Auditors.** Two Auditors shall be appointed at each Annual General Meeting. They shall inspect the books and accounts of the Association for the calendar year in which they are appointed and shall present their report to the Executive Committee not later than June 15th of the following year. The Executive Committee shall cause same to be published in the first edition of the weekly or printed and made available for distribution among the members not later than July 15th.

## 9. Elections and Nominations.

A. Election of officers shall be held on the day of the Annual General Meeting, by ballot, and all junior and privileged members shall be allowed to vote.

B. Nominations shall be made on official forms to be supplied by the Association at least ten days prior to date of closing of nominations and all nominations shall be posted on official bulletin board one week prior to the elections.

C. No nomination shall be valid without the signature of the nominee.

D. The Secretary-Treasurer shall, on behalf of the Association, procure, or cause to be procured a suitable box, with lock and key, for the reception of nominations and ballots. It shall have a suitable opening made in such manner that the nomination forms or ballots may be conveniently deposited herein, but may not be easily withdrawn while the box is locked. The box shall be locked one week prior to closing of nominations, when the box shall be opened and names of candidates posted by the Secretary-Treasurer.

During such time it shall be accessible to members of the association at convenient hours of each day or evening or both for the purpose of depositing nomination papers and no nominee shall withdraw after his or her name has been officially posted.

When the nominations are closed the box shall immediately be opened by the Secretary-Treasurer in the presence of at least five members of the Association. Should it be found, upon opening the box, that an insufficient number of nominations have been received for any office or any Governing Committee, the nominations for such office or position shall be re-opened, and shall remain open for a further forty-eight hours, and the Secretary shall cause notice to that effect to be posted on the official bulletin board. But such re-opening of the nominations shall not cause a corresponding postponement of the General Elections.

The candidates for the Executive Committee may be selected for nomination as follows:

The member or committee in charge of each section (Baseball, Basket Ball, Bowling, Tennis, etc.) may call a meeting of all the players in his section at

least one week prior to the date set for receiving nominations. At this meeting the players may select (by ballot if necessary) at least three, and not more than five candidates for nomination to represent them on the Executive Committee and to govern the section. All such names shall appear on the ballot at the general elections of the Association, in their own section.

The candidate receiving the highest number of votes in each section shall be declared elected to the Executive Committee.

10. Duties of Officers—President, shall be the chief executive officer of the association, he shall preside at all the meetings of the association and of the executive committee, he shall enforce all the rules and regulations, be ex-officio a member of all committees, he may call a meeting of the association at his pleasure, and shall do so at the request of ten senior members of the association, within three days of the receipt of such notice.

Vice-President, shall assist the President in the discharge of his duties, and in his absence act in his stead.

Secretary-Treasurer, shall keep or cause to be kept a true and correct record of all meetings of the association, and of the executive committee, shall keep a correct roll of all association members and conduct all correspondence, receive all moneys due the association and deposit same to the credit of the association in an approved chartered bank. He shall pay by cheque all bills or claims against the association which have been bona fide incurred on recommendation of the executive committee and which have been approved of by them for payment. All cheques shall be signed by Secretary-Treasurer and countersigned by the President or Vice-President.

Executive. The executive shall hold office for one year or until their successors shall have been elected or appointed: Their duties shall be to act as a membership committee and establish and enforce penalties for infringement of this constitution. They shall have control of all the property and assets of the association. shall have power and authority to expend in improvements, alterations or additions to the association's property, or for other purpose by them deemed advisable, and

in the interest of the association, such sum or sums as may from time to time be required, provided, however, that the annual expenditure shall in no case exceed the annual revenue; they shall settle all disputes referred to them. They may appoint an Assistant-Secretary-Treasurer and may select sub-committees to promote and control such games, sports or amusements as may be assigned to them.

**11. Vacancies in Executive Committee.** Any vacancy which may occur on the Executive Committee or on any Governing Committee, shall, whenever possible, be filled by the defeated candidate who received the greatest number of votes in the section, or for the office through which the vacancy occurs, otherwise the appointment shall be left to the judgment of the Executive Committee. For this purpose the Secretary-Treasurer shall retain an accurate list of all votes received by each candidate.

**12. Quorum.** Eight members of the executive shall constitute a quorum, any member who shall, without good and sufficient cause, of which the executive committee shall be the judge, absent himself from three consecutive committee meetings, shall cease to be a member of the executive committee.

**13. Meetings.** The annual meeting of the association, of which one week's notice must be given, and at which the election of officers shall take place, shall be held during the last week in August: twenty-five members present forming a quorum.

The Secretary shall call a general meeting at any time at the direction of the President, or on a requisition signed by not less than ten senior members of the association. In all such cases,

matters to be dealt with or discussed, must be specifically stated, and three clear days' notice given.

The executive committee shall meet at least once a week during the summer season, and not less than once in every two months during the balance of the year.

**14. Amendments and Appeals.** This Constitution may be amended or repealed by a vote of two-thirds of the members present at a general meeting of the association, provided that the proposed amendments or repeals have been submitted to the executive committee, and a notice of the general character of such changes, posted on the notice board one week previous to the meeting at which action is to be taken.

**15. Misconduct.** Should the conduct of any member of the association be, in the opinion of the executive committee after investigation, injurious to the character and interests of the association, or should any member refuse to conform to any rule or regulation of the association which from time to time may be made by the executive committee, or who should be guilty of unfair or unsportsmanlike action, he shall be requested to resign. Should this request not be complied with within one week, his name shall forthwith be struck from the membership roll.

**16. Amateur.** An amateur is one who does not compete with or against a professional.

A professional may participate in the local sports but must not participate on a representative team playing for a trophy.

**17. Colors.** The official colors of the association shall be Royal Blue and Crimson.
