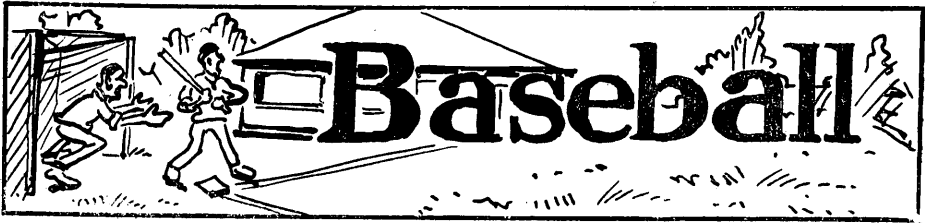

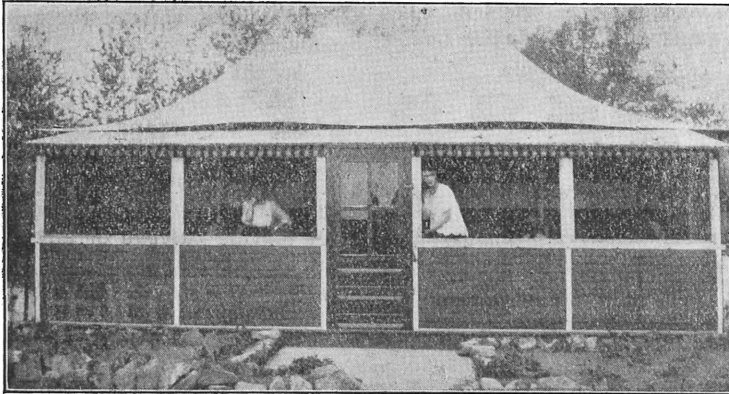
## CHILDREN'S MASQUERADE

## Constitution Ward's Island Association.

As amended July 25, 1921.

**1. Association.** The association shall be called, "Ward's Island Association."

**2. Location.** The home of the association shall be that portion of the island of Toronto beginning at the west end of lot No. 1 being that lot lying immediately west of house No. 166 Lake Shore Avenue, and extending east to the westerly pier of the channel at the easterly end of the island.

**3. Objects.** To provide the members thereof with suitable accommodation, means and appliances for the pursuit and promotion of aquatic and other amateur sports or pastimes, and to promote the general interests of the residents of Ward's Island.

**4. Membership.** There shall be three classes of membership, viz., Senior, Junior, Privileged.

**Section A.** Senior membership shall consist of members sixteen years of age and under, residents of Ward's Island, who shall be entitled to all the privileges of the association.

**Section B.** Junior membership shall consist of members fifteen years of age and under, residents of Ward's Island who shall be entitled to all the privileges of the association except the right to vote.

**Section C.** All members in section A and B shall be bona fide residents of Ward's Island for a period of at least thirty days prior to August fifteenth.

**Section D.** Privileged membership. Temporary residents of Ward's Island or visitors may become privileged members on payment of the regular fee. As such they shall be entitled to all privileges of the Association excepting the right to vote or to participate in the Annual Aquatic or field day events.

**5. Fees.** The annual fees shall be payable in advance and must be paid not later than the fifteenth of June in each year.

The annual fees shall be as follows:

With reference to clause No. 6—Fees—your committee is of the opinion that the Annual Fees should be fixed at a rate which will place the Association on a self-sustaining basis and recommends that the matter be given the immediate consideration of the Association.

**6. Officers and Committees.** The Executive of the Association shall consist of Hon. Pres. (Retiring President), President, Vice-President, Secretary-Treasurer, and a Committee of eleven members of the Association—two of whom shall be ladies—one representing senior and one representing junior ladies sports.

**7. Auditors.** Two Auditors shall be appointed at each Annual General Meeting. They shall inspect the books and accounts of the Association for the calendar year in which they are appointed and shall present their report to the Executive Committee not later than June 15th of the following year. The Executive Committee shall cause same to be published in the first edition of the weekly or printed and made available for distribution among the members not later than July 15th.

**8. Elections and Nominations.**

**A.** Election of officers shall be held on the day of the Annual General Meeting, by ballot, and all but junior and privileged members shall be allowed to vote.

**B.** Nominations shall be made on official forms to be supplied by the Association at least ten days prior to date of closing of nominations and all nominations shall be posted on official bulletin board one week prior to the elections.

**C.** No nomination shall be valid without the signature of the nominee.

**D.** The Secretary-Treasurer shall, on behalf of the Association, procure, or cause to be procured a suitable box, with lock and key, for the reception of nominations and ballots. It shall have a suitable opening made in such manner that the nomination forms or ballots may be conveniently deposited herein, but may not be easily withdrawn while the box is locked. The box shall be locked one week prior to closing of nominations, when the box shall be opened and names of candidates posted by the Secretary-Treasurer.

During such time it shall be accessible to members of the association at convenient hours of each day or evening or both for the purpose of depositing nomination papers and no nominee shall withdraw after his or her name has been officially posted.

When the nominations are closed the box shall immediately be opened by the Secretary-Treasurer in the presence of at least five members of the Association. Should it be found, upon opening the box, that an insufficient number of nominations have been received for any office or any Governing Committee, the nominations for such office or position shall be re-opened, and shall remain open for a further forty-eight hours, and the Secretary shall cause notice to that effect to be posted on the official bulletin board. But such re-opening of the nominations shall not cause a corresponding postponement of the General Elections.

The candidates for the Executive Committee may be selected for nomination as follows:

The member or committee in charge of each section (Baseball, Basket Ball, Bowling, Tennis, etc.) may call a meeting of all the players in his section at least one week prior to the date set for receiving nominations. At this meeting the players may select (by ballot if necessary) at least three, and not more than five candidates for nomination to represent them on the Executive Committee and to govern the section. All such names shall appear on the ballot at the general elections of the Association, in their own section.

The candidate receiving the highest number of votes in each section shall be declared elected to the Executive Committee.

**9. Duties of Officers—President.** shall be the chief executive officer of the association, he shall preside at all the meetings of the association and of the executive committee, he shall enforce all the rules and regulations, be ex-officio a member of all committees, he may call a meeting of the association at his pleasure, and shall do so at the request of ten senior members of the association, within three days of the receipt of such notice.

**Vice-President,** shall assist the President in the discharge of his duties, and

in his absence act in his stead.

**Secretary-Treasurer,** shall keep or cause to be kept a true and correct record of all meetings of the association, and of the executive committee, shall keep a correct roll of all association members and conduct all correspondence, receive all moneys due the association and deposit same to the credit of the association in an approved chartered bank. He shall pay by cheque all bills or claims against the association which have been bona fide incurred on recommendation of the executive committee and which have been approved of by them for payment. All cheques shall be signed by Secretary-Treasurer and countersigned by the President or Vice-President.

**Executive.** The executive shall hold office for one year or until their successors shall have been elected or appointed. Their duties shall be to act as a membership committee and establish and enforce penalties for infringement of this constitution. They shall have control of all the property and assets of the association, shall have power and authority to expend in improvements, alterations or additions to the association's property, or for other purpose by them deemed advisable, and in the interest of the association, such sum or sums as may from time to time be required, provided, however, that the annual expenditure shall in no case exceed the annual revenue; they shall settle all disputes referred to them. They may appoint an Assistant-Secretary-Treasurer and may select sub-committees to promote and control such games, sports or amusements as may be assigned to them.

**10. Vacancies in Executive Committee.** The executive committee are authorized and empowered to fill any vacancy which may occur in their ranks, or those of the officers, at a special meeting to be called for that purpose, and of which two days' posted notice must be given.

**11. Quorum.** Eight members of the executive shall constitute a quorum, any member who shall, without good and sufficient cause, of which the executive committee shall be the judge, absent himself from three consecutive committee meetings, shall cease to be a member of the executive committee.
